### **Forensic Chemist I**

# Scope:

• The Forensic Chemist I is responsible for performing routine chemical analyses on suspected controlled substances submitted to the Pinellas County Forensic Laboratory.

#### **Education, Training, Experience and Qualifications:**

- Bachelor's degree in Chemistry or Forensic Science or other Natural Science from an accredited
  college or university with a minimum of 30 credit hours of chemistry including instrumental
  analysis.
- Computer Literacy Windows 95/98 or Windows NT.
- Successful completion of Pinellas County Forensic Laboratory Training Program.

#### **Duties and Responsibilities:**

(Note: The following duties and responsibilities are not descriptive of any one position. The omission of a specific statement does not preclude the assignment of that task to this class.)

- Performs routine and complex analyses of suspected controlled substances.
- Provides accurate and timely chemical analysis of assigned cases.
- Participates in quality control and proficiency testing on a scheduled basis.
- Calibrates analytical instrumentation on a routine basis.
- Performs and records routine maintenance on laboratory instrumentation and equipment.
- Testifies in court as an expert witness on laboratory analyses, results, policies, and procedures.
- Maintains all continuing education/training and proficiency testing requirements for the position.
- Provides forensic science presentations to the general public.
- Provides specialized training to law enforcement community.
- Reviews applicable literature to stay current in new laboratory procedures and technology.
- Inventories lab supplies and coordinates purchase.
- Assists in the evaluation of new procedures and techniques for possible laboratory implementation.
- May perform administrative review of casework.
- Assists in administrative duties as needed.

### **Knowledge Required:**

- PCFL Policies and Procedures .
- Rules of evidence as they relate to the criminal justice system and the preservation of evidence.
- Basic scientific principles and practices.
- Theory and operation of applicable analytical instrumentation.
- Use of instrument specific software as well as Word, Excel, and PowerPoint.
- Chemical identification processes as they pertain to controlled substances.
- SWGDRUG QA Documents.

# **Skills Required:**

- Sample preparation and drug isolation techniques.
- Operation of laboratory instrumentation including GC, MS, UV/VIS and IR.
- Establish and maintain professional and courteous relationships with fellow employees and member of other departments and organizations.
- Team building/team working skills.

#### **ADA Requirements**

#### Physical Demands:

- Laboratory and administrative office work involving the use of scientific instruments, telephones, computers and general office equipment.
- Work requires ability to lift, pull, push, feel, see (color, acuity, depth perception), carry, walk, stoop, kneel, bend, handle, talk and operate
  - fixed and cellular telephones,
  - computers,
  - laboratory equipment, and
  - office equipment.

#### **Environmental Demands:**

- Involves work in indoor laboratory environment.

  - analyze information and develop conclusions,
  - write complex sentences relaying information, data and details,
  - testify in court,
  - speak clearly and concisely when relaying information,
